



## APPLICATION FOR REALTOR® MEMBERSHIP



To the St. Thomas Board of REALTORS® ("STBOR"), I hereby apply for REALTOR® Membership in the above named Board and am enclosing my check in the amount of \$ **100.00** for a one time application fee for brokers/agents and \$295 for designated brokers/branch managers/new companies. The annual dues shall be *in such amount as established annually by the Board of Directors*. Dues are to be made payable to St. Thomas Board of REALTORS®. My \$100 application fee is non-refundable.

In the event of my election, I agree to abide by the Code of Ethics of the National Association of REALTORS®, which includes the duty to arbitrate, and the Constitution, Bylaws and Rules and Regulations of the above named Board, MLS, the State Association and the National Association, as they exist and as they may be amended from time to time, and if required, I further agree to satisfactorily complete a reasonable and non-discriminatory written examination on such Code, Constitutions, Bylaws and Rules and Regulations. I understand membership brings certain privileges and obligations that require compliance. Membership is final only upon approval by the Board of Directors and may be revoked should completion of requirements, such as orientation, not be completed within timeframe established in STBOR's bylaws. I understand that I will be required to complete periodic Code of Ethics training as specified in the association's bylaws as a continued condition of membership.

I irrevocably waive all claims against the Board or any of its officers, directors, members, and/or employees for any act in connection with the business of the Board, and particularly as to its or their acts in electing or failure to elect, advancing, suspending, expelling, or otherwise disciplining me as an applicant or as a member, and to agree that neither the Association nor any officer or employee thereof, nor any member of the Board of Directors or other committee, shall be liable, except for willful malfeasance, to the applicant, for action taken by such officer or member of the Board of Directors or other committee in his official capacity, or by any employee of the Board or Committee of the Association, in connection with the administration or enforcement of any of the provisions of the Bylaws, any of the rules and regulations as they are, or may from time to time be adopted, changed or amended, or any rulings, orders, direction, decision of, or penalty imposed by the Board or Directors or any duty authorized committee. Upon the expiration of said membership for any cause I will discontinue the use of the designation REALTOR® and return to the Board all certificates, signs, seals, Multiple Listings or other indications of membership in the St. Thomas Board of REALTORS®, the Virgin Islands Territorial Association of REALTORS® and its Multiple Listing Service, and the National Association of REALTORS®. I agree that if accepted, my membership in the Board shall not constitute a property right.

I also agree to scrupulously abide by the Virgin Islands Real Estate License Act, the Rules and Regulations of the Virgin Islands Real Estate Commission, the Code for Equal Opportunity of the St. Thomas Board of REALTORS® and, if I become a Participant or Subscriber of VITAR MLS to comply with all MLS Rules and Regulations. As a member of the St. Thomas Board of REALTORS® I agree to submit to arbitration by a panel of the Professional Standards Committee (and to be bound by the decision of the panel) all disputes with other members in accordance with the bylaws and the Code of Ethics and Arbitration Manual of the St. Thomas Board of REALTORS®, VITAR and NAR, and to sign any document or documents reasonably necessary to accomplish such submission.

Applicant acknowledges that if accepted as a member and he/she subsequently resigns from the Board or otherwise causes membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon applicant's certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while applicant was a REALTOR®.

- REALTOR® Assistant: Broker, salesperson or appraiser (licensed and/or certified) who is associated with a Designated REALTOR® and who has fulfilled membership requirements in local, state and national Board of REALTORS® and who engages in any form of real estate including: buying, selling, appraising, writing offers and/or any other option for a REALTOR® for whom they are working.

- The appropriate processing fee

4. Take and pass NAR's Code of Ethics. See [realtor.org](http://realtor.org) to register and take the required course. New Member Orientation is a requirement for membership. New members will be notified of the Orientation schedule.
